The mandatory safety standards covers:

- All Gas appliances Reform 52
- All Electrical appliances Reform 52
- All Smoke alarms Reforms 51 & 53
- Residential Tenancies Regulations 2021 Part C Safety related activities
- Tampering with safety devices is deemed grounds for issuing renter a notice to vacate

Non-Compliance

Failure to meet the standards will result in heavy fines, public blacklisting on a Consumer Affairs Non-Compliance Register as well as providing grounds for your insurer to void your insurances should anything happen to your building or your renters.
